Network Rail wishes to procure a new supply framework for hardwood and softwood timber sleeper and bearers and baseplates and associated items. The tender is divided into five lots - two lots for timber sleepers and bearers, three lots for baseplates and associated items.

Lot 1 covers the supply of hardwood timber sleepers and bearers both plain, drilled or with free-issued baseplates attached.

Lot 2 covers the supply of softwood timber sleepers and bearers both plain, drilled or with free-issued baseplates attached. All softwood timber sleepers and bearers will need to be treated with an alternative wood preservative to Creosote which is compliant to Network Rail's specification.

Lot 3 covers the supply of Grey Cast Iron Baseplates, Lot 4 includes the supply of Spheroidal Iron Baseplates and Lot 5 covers the supply of Steel Baseplates. These baseplates are for use on both the new timber sleepers and bearers and for maintenance on both Network Rail's plain line and switches and crossings.

Parties who wish to participate in the tender are required to submit compliant bids but they may also submit variant bids. Variant bids shall be evaluated in accordance with the published tender evaluation criteria and Network Rail reserves the right not to accept any variant bid. The tender pricing model shall be used to price any variant bid. The variant bid must comply with all minimum standards applicable and must meet all performance requirements stated in the technical specification.
